#### From the desk of Faye Spencer KAFCE State Vice President

The article written for the March 2013 issue gave suggestions of how to present lessons that are interesting, encourage audience attention and their interaction. Bottom line, as stated many times from the 2012 Program Evaluation, DO NOT READ the lesson, put some effort and heart into it.

Another topic for suggestive improvement is the completion of the front page of the FCE Accomplishment Report. The first steps should have been to select the lesson that the report will be based upon and to select the category-education, leadership or action. With this information, objectives or goals may be written.

Goals and objectives are similar. They describe the intended purpose and expected results or outcomes of the lesson's instructional activities. Writing an objective statement will provide the basis for selection of the learning materials, content, delivery method and opportunity to organize the learning process. After the activity, the goals and objectives will be used to evaluate if the intended purpose and results were achieved.

There are three instructional and learning styles. Goals and objectives may be written according to the desired style. The following list is a very short list of possible verbs that may be used.

- Cognitive objectives for knowledge: "What do you want learner to know?"
  - Write statements using such verbs as recall, apply, estimate, write, and test.
- Affective objectives for attitude: "What do you want learner to think or care about?"
  O Write statements using such verbs as: support, participate, praise, and join.
- Psychomotor-skill objectives for hands on learning: "What do you want learner to be able to do?"
  - Write statements using action verbs such as: repair, measure, operate, or move.

On the back of the accomplishment report are the descriptions of the categories. I would like to help clarify Leadership. Janie Williams wrote in the December, 2012 issue a very well written example of how an education category program may lead to a leadership category program. When "guiding a program/project from beginning to end, using training methods that empower others to teach others."

The <u>beginning</u> would be the individual's or FCE unit's initial presentation with others in attendance. The "others" are people who do not have FCE membership and could be another organization. Tabulation data should be recorded.

Next, this organization uses the same educational program to instruct their membership. The original FCE has "guided" further learning, thus provided leadership.

"To the end" is to follow that other organization. What were the other organization's Actions, Results and Evaluation? What were the numbers of people they reached? Did they publish the program in a local newspaper? Did they do a booth? The original FCE will need to add to the initial tabulation data with the tabulation data of the other organization's educational program.

The accomplishment report will summarize the whole process-beginning with them learning and ending with them teaching.
