"the gift"

Many of you have heard about "the gift" and all of you should have received your penny by the time you read this. Here is the basic explanation of "the gift" in case you missed exactly what is happening. This is NOT "Pennies for Friendship", this is a totally new project called "the gift".

1. This is my gift to the membership of KAFCE – no state funds were used for this project.
2. If you save a penny a day for a year (and we started the project at State Conference, Oct. 2) you will have saved \$3.65.
3. Since this is a gift, I am asking that you "re-gift" it when you pay your dues for **2014** in October of 2013 as follows:
 - \$.50 to National FCE
 - \$.50 to Kansas FCE
 - \$.50 – each to 5 different other KAFCE contributions
 - OR \$.50 to 2 different projects
 - AND some to your local FCE and/or county

The National organization and **your** state organization can not survive on the amount of money that they are receiving for dues. Saving a penny a day is something that we can ALL do to help support "our" organization.

Explanation of the Leadership Award

It seems that our members and units have a hard time in understanding the difference between the FCE educational program awards of Education and Leadership. Not very many units apply for the Leadership award because they feel it is to hard to accomplish or they really don't understand the concept.

The best way I can explain it is:

Leadership is an extension of Education.

EDUCATION is when an individual or unit presents an educational program/project for learning by using NAFCE or KAFCE program material. They count the number of persons reached and the number of FCE members and others involved with the action/activity.

EXAMPLE- Mary or the Yes I Can unit presented the educational program "Money-Money" to the local Senior Center. They enlisted the help of two persons from the Department of Aging. There were 22 in attendance and 11 members from the unit giving information.

LEADERSHIP is taking this same example and using the same program and guiding the activity from beginning to end. Mary or the unit would help the Senior Center extend their learning to more persons in the community. They could team up and offer this information to extended groups such as taking it to Senior Living or their individual church groups. Record all the groups and numbers reached.

The important part of these accomplishments is to plan or make goals early in the year, not wait until it is time to fill out the report and try and decide which category fits your activity.
