National FCE and ACWW USA Area Conference – Held July 21 – 25 in Erlanger, KY. My, was this an eye opener!!!! Thank you to all of you who have sent their dues promptly. I received several at the State Conference in Dodge City. This gave me a head start on entering data in a spreadsheet to be sent to National FCE headquarters.

Most Members filled out their membership forms with due diligence. However, others had missing information such as birth dates, date joined, emails, middle initials, and phone numbers. One county's forms lacked the members' signatures; thus they had to be returned to them.

I know it seems ridiculous that we fill out the same information year after year, but I need to know if this information has changed. When I am typing the information into a spreadsheet, I get the information straight off the membership form you sent. The original member's form is sent to the National FCE Headquarters. If the information is not there, then I must find out the information by going to a previous spreadsheet. Granted, I can do that. But when I send the forms to National, that means they are incomplete and could be sent back, causing extra cost to both National FCE and Kansas FCE.

The auditors, and in turn the IRS, will question how Membership dues can sustain our organization. Proving the source of our funds since September 11, 2001 has been a key issue. We need to validate every member with a <u>signed</u> form for the proper year. Not all our 2025 members renewed their membership for 2026. The final numbers are not in yet, but it looks like we have lost many members. FCE Units are reporting that some of our members chose not to renew.

I have received contributions from counties, and I appreciate your generosity.

There is still time to donate if you have not sent them in. Those will all be passed on to the respective charities at the end of the year. Kansas FCE has many projects to support, including Kansas FCE Scholarship Program, Joann Newby Scholarship Program, as well as many National FCE Projects.

Additionally, we provide financial support to various ACWW initiatives. Your donation can make a difference to the impact we make globally. From local projects and activities to international efforts to safeguard the rights of rural women, your support is vital. The Pennies for Friendship project has been renamed by ACWW as the Rural Women in Action Project.

Our members have donated to these programs for many years. The donations we collect every year go to fund-needed projects. Such as;

Smurthwaite is an all-female hall that houses approximately forty-five women on the east side of the K-State campus. Smurthwaite residents must participate in leadership programming and maintain a 3.0 cumulative GPA.

Clovia House -A long title is Alpha of Clovia 4-H Cooperative Leadership House. Officially the chapter is Alpha of Clovia Inc as a business entity as we are the Alpha chapter as the first Clovia. There is a Beta chapter at the University of MInnesota and others over the years but are no longer in existence. Our founding members in 1931 had the common thread of being former 4-H members and that has historically been our continued ties and those 4-H principles are what the Clovia principles are based on. Our house at 1200 Pioneer Ln. was originally a project of the Kansas 4-H Foundation and they served as our landlords until Spring 2024 when the Clovia Alumnae Association was able to negotiate a purchase of the house from the Foundation.

CHARACTER COUNTS! ® High School Age Essay Contest – this is a new project for Kansas FCE. We will be offering a \$100 award to the winning High School Student who wins the Essay contest. This has been budgeted as a \$100 award.

Smith County has offered to donate to the next year's winner (2026), and Gray County has offered to donate to the year after that (2027). I am so excited about these donations. The winner this year is Forrest McKinney, from Leoti, Kansas, who won third place at the National FCE level.

Contact local officials (city, county, school, youth groups, clubs) for ideas—do they need support in their projects? Would they like to partner with us on our projects?

Check the local food pantry, health department, senior citizen centers for their needs.

Contact schools regarding their extracurricular activities, or reading activities for children.

Offer Friday evening babysitting for young couples to have a date night (host at a church basement, YMCA, or a day care facility for a safe, neutral environment) with games and activities for the kids (2-hour limit recommended).

Projects may involve areas outside our counties.

Look for areas that could use some beautification.

President-elect shall serve a one-year term (2027) followed by a three-year term (2028-2030) as President. The President-elect will fulfill duties as may be assigned by the President or the Board of Directors.
