Commemorating the 200th year of the Santa Fe Trail

Commemorating the 200th year of the Santa Fe Trail was the theme of the entertainment for the annual meeting of the Kansas Association for Family and Community Education on October 5, 2021 in Topeka. Jeff Davidson brought his "history by song" presentation to the meeting and emphasized not only the Santa Fe Trail, but the important role that locomotives played in replacing the trail. The story of the Santa Fe Trail is immense, and much of the development of Kansas has a Trail connection.

The Santa Fe Trail was used for six decades and is the oldest route through the Great Plains. It was a trail of commerce beginning when Mexico revolted from Spain and won their independence. Spain had discouraged trade, but Mexico welcomed it, and the story of the American west and Mexico north cannot be told separately. Trade between Missouri and Santa Fe opened up a mix of cultures, with Anglo people of the US, the Spanish people of Mexico, and Native Americans. For the most part, these cultures got along fairly well, but the Native Americans were exploited by both the American and Mexican cultures, thus leading to conflict on the frontier.

As railroads built west in the 1860's, the trail became shorter, and varied in its route. The Kansas Pacific Railroad marched across Kansas and several towns served as the eastern terminus of the Trail. Five years after the Kansas Pacific Railroad started, the Atchison, Topeka and Santa Fe (ATSF) Railroad began from Topeka, competing with the Kansas Pacific Railroad. The ATSF won the right-of-way over Raton Pass, a mountain pass between Trinidad, Colorado and Raton, New Mexico, reaching Santa Fe in 1880.

The Trail was a catalyst for change. It spelled the end of a way of life for Plains Indians, and brought change to the Hispanic population of New Mexico as they became US citizens following the Mexican/American war of 1846-48.

While the Santa Fe Trail originally connected old Mexico with the United States at Missouri, for most of its' years, the trail essentially began at the territorial line of Kansas and it's Kansas that has the most miles of the Trail. The Trail generated the settlement and development of both Kansas and New Mexico.

In 1987, recognizing its national significance, the US Congress designated the Santa Fe Trail a National Historic Trail.

Using nine songs, Davidson shared how the Trial influenced the economy, ideology and heroism of the developing state of Kansas.

OFFICER REPORTS:

President –Nancy Kernick thanks all who work with her in making decisions, and planning the KAFCE year and has shown her appreciation as being our President.

-- August Mailing – President Nancy put together and emailed materials on August 26, 2021.

--American Income Life Insurance Company (AIL) – Every member has a \$4,000 Policy. Each year AIL mails to current members the Information Designating the Beneficiary (Yellow) card, thus updating the member's policy. AIL will donate to KAFCE based on the number of returned cards. The company donated to KAFCE in 2019 the amount of \$50.00. Following the 2021 Conference, the company again donated to KAFCE \$50.00.

--KAFCE Scholarship Award – Income from a July, 2021 shipment of collected ink cartridges earned the Scholarship Fund \$297.80. By consensus of the Board, scholarships were awarded.

Please continue to save ink cartridges.

<u>--NAFCE Liability Insurance</u> – Membership was increased by \$5.00 for three years, 2020, 2021, and 2022, to help cover the expense and after this year they will review the Insurance premium.

Vice President –Faye Spencer, has attended ACWW, National and State meetings. EPC judging was done by mailing Area winning reports to each State EPC member. On a ZOOM meeting, award winner placements were discussed and finalized. There was not a NAFCE Program Award competition. State EPC Leadership Training was held by ZOOM. Thanks to the 2020 Chair Linda Hess of SC Area, 2021 Chair Cindy Kiser of SE Area, and 2023 Chair Tina Bailey of NE Area. Jennine Marrone of SE Area is the newest member and will be the 2024 Chair. At the State Conference banquet, State Award Winners were recognized and received certificates of achievements. All FCEs should complete the 2021 KAFCE Educational Program Evaluation and mail to Faye Spencer by December 1, 2021.

Treasurer –DeLores Walden – Budget: KAFCE has an ending balance in the treasury as of September 30, 2021 of \$30,393.37. Budget Report for 2022 was presented by DeLores Walden during State Annual Meeting. The amount of \$27,425 was based on a projected 2022 membership total of 600 and with the 2022 KAFCE Restricted Funds Budget at \$350.00.

Treasurer – 2022 Membership Dues Forms were received at State Conference. Otherwise, signed forms and payment are to be sent to State Treasurer, DeLores Walden, by December 1, 2021, to avoid a late fee penalty of \$1.50 per member. New members can be received any time during the year. Senior membership fee applies to anyone that will be eighty (80) by 12/31/2021.

STATE NOMINATING COMMITTEE – PAT WEISHAAR. At the State Annual Meeting, Pat Weishaar, chair, announced the candidates for president, secretary, and treasurer.

Vice-President Faye Spencer presided over the election. Nomination speeches were given by: Nancy Kernick, president for another 3-year term (2022, 2023 and 2024),

Marlene V. Faul, secretary for 1-year term to fulfill the unexpired term (2022);

DeLores Walden, treasurer for another 3-year term, (2022, 2023 and 2024).

With one candidate per office, a voice vote was taken and all three were elected.

**Vice President Faye Spencer is extending her term two years, (2021-2022).

STANDING COMMITTEE REPORTS:

State Educational Program Committee – **LINDA HESS** - Lessons for 2022 were written and printed. Packets were filled and distributed to State Officers, KSU Advisor and FCE Representative, Area Directors, Area EPC members, and County Council EPC, Unit EPC and Independent Members.

State EPC Leadership Training was held on August 30, 2021 by ZOOM. The meeting was facilitated and chaired by Faye Spencer, State Vice President. There were 12 to 20 people who attended. Contents of the State EPC Leader Training folder were reviewed. Changes for 2022 were noted. Accomplishment Reports for FCE Units, County Councils and Independent Members will use the same form and will need to be identified when filled out.

100% Reporting: Completing the tabulated data and returning Accomplishment Report forms will be necessary for all FCE Units (even if unit disbands by end of the year) to be eligible for 100% Reporting for the county and area. Judging for awards will be optional.

Marketing Committee – Dorene Reimer - We had the Marketing table at Conference in October and supplied merchandise to others who will sell at Area Meetings. No new items were purchased for the merchandising inventory since there were no selling opportunities in 2020 and very limited meetings in 2021. There was a face-to-face meeting in the SW Area for a nice sales total, thanks to Linda Leonard, one of the three State Marketing Committee members. I also did a few separate sales for some FCE Units wanting to make gift baskets for long time members or all members of an FCE unit or items for an FCE basket for a community auction. All of these sales brought in a total of approximately \$300.00 plus. Table favors were purchased for Conference.

Registration was 59 including 2 non-members and 2 FACS agents. Self-guided tours were Monday afternoon and Tuesday morning. Make & Take (trivets and button bracelets) were Tuesday morning. The Prizes of the Yard earned \$825.00. Annual meeting opened the Conference followed by officers training and ended on Tuesday. The banquet was a chicken dinner with chocolate mousse for dessert not a drop was left. Following the banquet, we recognized the 2020 Heart of FCE Ruth Meyer, Nemaha County and 2021 Heart of FCE Judy Emert, Nemaha County; Character Counts! Essay & Art winner Daniela Fortanel, Wichita County; Past presidents Sharon Giacometti, Crawford County and Dorene Reimer, Wichita County; and the Program EPC Awards were presented with an explanation of the lesson and placing.

Tuesday Lunch was a prepared box lunch and enjoyed by all. The 1st Timer Jeanine Rishel, McPherson County was recognized and received a check for her registration, introduction of County Presidents (13) and Outgoing officers, and Installation of 2022 KAFCE Officers.

Announcements: Following the business meeting, everyone had a break, and then the Officer Training took place and everyone was expected to attend as we all are officers at one time or another. There were 25 in attendance. The Officer Training meeting was from 3:20 to 4:20 pm, with Nancy Kernick, president; Faye Spencer, vice president; Marlene V. Faul, acting secretary; DeLores Walden, treasurer, and Parliamentarian responsibilities were read by Nancy Kernick in the absence of Judy Fulmer. Dorene Reimer, chair of the Handbook Committee gave her report.

Officer's Training during the KAFCE Conference, had a workshop for treasurer. If you would like that information, email DeLores Walden and she can get that to you. It is very important to watch deadline dates, use the correct form, and scams that can be in your email, by phone, or by mail.

Banquet, Program, and Luncheon Speeches at the State Conference were given by:

Chris Cruz, Topeka, Kansas, gave a great presentation at Monday's banquet on Fred Harvey and Fast-Food meals. "How Fred Harvey's Topeka Depot Restaurant Changed our Expectations for Fine, Fast Food". The famed Fred Harvey concept began in a Santa Fe depot in Topeka, Kansas in 1876. Growing quickly along the Santa Fe Railroad System and was emulated by other railroads as they competed for customers. To this day, Fred Harvey service has changed how the public perceives good "FAST FOOD."

Mary Dunn, Neosho County FCE Member, presented on Tuesday morning, information about Clovia 4-H House. Alpha of Clovia is a 4-H Cooperative Leadership House located near the Manhattan campus of Kansas State University. It was started in 1931 as a 4-H scholarship house for women to live in a cooperative manner, sharing housework and possessions to reduce the overall cost of living, and to provide an opportunity for a homelike, friendly atmosphere while pursuing an education. The Alpha of Clovia living costs include all meals, rent, utilities, printer access, internet, laundry facilities, as well as parking availability. The present brick house on Pioneer Lane was opened in 1967, and has room for 62 women. A Beta of Clovia organization was organized at the University of Minnesota at St. Paul, Minnesota in 1938.

Throughout the years, women from various backgrounds across the country have become Clovia members, participating in activities, such as: philanthropies, house retreats, the annual national Clovia meeting and homecoming, among other social events. All of these activities and more are done while maintaining a high sense of academic scholarship while studying at Kansas State University. For women to be eligible to live in Clovia they must enroll as a full-time student at K-State, have some form of leadership background, 3.0 GPA for high school seniors, or a 2.65 GPA for transfer students.

I was a transfer student to K-State in 1968 and was fortunate enough to live in the brand-new house. My two daughters both lived in Clovia in the late 1990's and early 2000's. Now our granddaughter is living there. We will all be Clovia sisters! The Alpha of Clovia 4-H Cooperative Leadership house is partially funded by the 4-H Foundation to take care of maintenance and repairs. Money for renovations is partially funded by donations from Alpha of Clovia Alumna, and donations from FCE groups, etc. The 4-H Foundation and Alpha of Clovia are both so appreciative of donations made to keep the Clovia House up and running and in good repair to continue to serve the needs of women attending Kansas State University.

Jeff Davidson, Eureka, Kansas, presented for the Tuesday's luncheon "Blood and Thunder-The Santa Fe Trail Story", a Kansan history, musical program, which emphasized the Santa Fe Trail and its 200th anniversary. Many songs were about trains, mule trains, wagon trains and railroad trains. (Ask Sharon G. if she enjoyed the music!). Details of his presentation may be found elsewhere in this newsletter.
