NOTES FROM DORENE

I have seen "FCE: On The Move!" for more than a year, and I am encouraged. Recently, I learned of Spring Creek FCE of Lane County, being chosen as Grand Marshalls of the annual Fair Parade. In order for this honor to be received, this FCE Unit has obviously been "Making A Difference" in that Community. Looking into its 86 year history, I discovered that Spring Creek FCE has long been, and continues to be, a valuable and well known organization in Lane County through their efforts to improve family and community life and through making a real difference. Congratulations Spring Creek FCE for this honor and for the fine example your unit is for Kansas FCE!

The Board has met twice since the February issue and this July issue of the "News." We began work in March with Handbook Revision and continued in June. The result is recommendations from the Board to revise seven different Bylaws which are published in this July issue. Please read and study them carefully. The recommendations will be voted on at the 2017 KAFCE Conference in Salina on October 3rd at the annual Business Meeting. All attendees must bring this "KAFCE News" July issue to Conference because no other copies of the proposed changes will be issued.

It has been the goal of the Board to reduce expenses related to printing hard copies. In evaluating the percent of Kansas FCE Members that receive the FYI booklet at Conference every year (about 10%) and the large amount of material that is repeated in the "News" publications, the Board has decided to no longer print the FYI booklet. Any information that is in only FYI will be moved to the appropriate "KAFCE News," which 100% of the Kansas FCE Membership receives. This necessitates eliminating the Area Directors' Reports. To help keep up with Area events, there will be an Area Calendar on the back page of each issue of the "News." This decision emphasizes again the need to keep each issue of the "News" for future reference.

Remaining focused on using Technology to help reduce expenditures, this year the August Mailing (aka Your 2018 Tool Kit) will be e-mailed to each County Council President and to each Extension Agent who has FCE(s) in his/her county or district. I have personally talked to many CC Presidents, and will, before August, have talked to all of them. If any don't have a computer and/or printer, we have located a contact that does. I believe this will be very efficient for our organization and its progress into the future.

Thinking toward 2017 Conference in Salina, a few items to remember to bring along: **address labels** for putting on the Barn Quilt Raffle tickets that you are going to purchase; your **Prizes By the Yard item(s)**; this **July "News" issue.** Check out the insert and be sure to note "early bird" registration dead-

lines. Encourage FCEers to apply for the First Timer's Scholarship - five of them will be given! I'm so looking forward to Conference - the schedule promises to be educational and fun. See you there!

PROPOSED AMENDMENTS TO KANSAS ASSOCIATION FOR FAMILY AND COMMUNITY EDUCATION BYLAWS

1. Amendment to Article II Object

Article II, now reads:

The object and purpose of this association, organized as a non-profit organization, shall be and is exclusively to strengthen, develop, coordinate, and extend education to improve the quality of life for <u>individuals and families</u>; and to determine and coordinate statewide policies; all within the meaning of Section 501 (c) (3) and Section 509 (a) (2) of the internal Revenue Code.

Amend Article II Object by striking the words "individuals and families" and inserting the words "individuals, families and communities" after the word for and before the semicolon. If adopted, the Article will read:

The object and purpose of this association, organized as a non-profit organization, shall be and is exclusively to strengthen, develop, coordinate, and extend education to improve the quality of life for <u>individuals</u>, <u>families</u>, and <u>communities</u>; and to determine and coordinate statewide policies; all within the meaning of Section 501 (c) (3) and Section 509 (a) (2) of the internal Revenue Code.

Rationale: This amendment adds the word <u>communities</u> which is part of our organization's name and purpose.

2. Amendment to Article III Members, Section 1

Article III Members, Section 1 A now reads:

A regular member pays KAFCE and NAFCE dues/fees and local/county dues/fees where applicable.

Amend Article III Members, Section 1 A by striking the words "A regular" and inserting the words "An individual" at the beginning of the sentence and before the word member so that if adopted, the Section will read:

An individual member pays KAFCE and NAFCE dues/fees and local/county dues/fee where applicable.

Rationale: This amendment will make the classification of individual member agree with the National classification.

Proposed by the Kansas FCE Board

3. Amendment to Article III Members, Section B

Article III Members, Section 1 B now reads:

A senior member is 80 or more years of age by January 1 of the membership year and pays KAFCE and NAFCE dues/fees and local/county dues/fees where applicable.

Amend Article III Members, Section 1 B by striking the word "by" and inserting the word "before" so that if adopted, Article III Members, Section 1 B will read:

A senior member is 80 or more years of age <u>before</u> January 1 of the membership year and pays KAFCE and NAFCE dues/fees and local/county dues/fees where applicable.

Rationale: This amendment clarifies when an individual qualities as a senior member.

Proposed by the Kansas FCE Board

4. Amendment to Article III Members, Section 1 C

Article III Members. Section 1 C now reads:

Family shall be defined as one or two adults and any children <u>under the age of 18</u> who live in the same household. They shall pay NAFCE dues as decided by NAFCE, and KAFCE dues in an amount equal to two <u>regular</u> memberships. If the children are over <u>18 in school</u> and living in the same household, they will continue as children until living under their own roof.

Amend Article III Members, Section 1 C by substituting the following Section 1 C:

Family shall be defined as one or two adults and any children 18 and under who live in the same household. They shall pay NAFCE dues as decided by NAFCE, and KAFCE dues in an amount equal to two individual memberships. If the children are over 18, in school, and living in the same household, they will continue as children until living under their own roof.

Rationale: This amendment clarifies membership for a child who is 18 years of age, changes regular to individual to conform to NAFCE classification, and inserts the editorial change of a comma in the next phrase.

5. Amendment to Article IV Dues, Fees, and Finances, Section 2 E

Article IV Dues, Fees, and Finances, Section 2 E now reads:

From time to time the Board of Directors may amend the current budget after considering recommendation of the budget committee.

Amend Article IV Dues, Fees, and Finances, Section 2 E by substituting the following sentence, so that if adopted, Article IV, Section 2 E will read:

The Board of Directors may amend the current budget after considering recommendation of the budget committee.

Rationale: This amendment eliminates the unnecessary "from time to time" phrase.

6. Amendment to Article IV Dues, Fees, and Finances, Section 3, sentence 3

Article IV Dues, Fees, and Finances, Section 3 now reads:

The financial record shall be reviewed annually by a committee appointed by the president. This committee will report to the Board of Directors. The financial records shall have an agreed upon procedure engagement by a certified public accountant at the end of each treasurer's term and submitted to the Board of Directors for approval.

Amend Article IV Dues, Fees, and Finances, Section 3 by striking the third sentence and inserting the following sentences: The financial records shall be audited by a Certified Public Accountant at the end of treasurer's term with an in-house audit at end of each of the first two years. A Certified Public Accountant can be consulted. If adopted, the Section will read:

The financial record shall be reviewed annually by a committee appointed by the president. This committee will report to the Board of Directors. The financial records shall be audited by a Certified Public Accountant at the end of treasurer's term with an in-house audit at end of each of the first two years. A Certified Public Accountant can be consulted.

Rationale: The amendment provides for an audit by a Certified Public Accountant at the end of the term and for an audit by members for the other two years of a treasurer's term. They may consult a Certified Public Accountant if there is a need.

Proposed by the Kansas FCE Board

7. Amendment to Article V Officers, Section 4

Article V Officers, Section 4 now reads:

A vacancy in the office of president-elect shall not be filled. A president shall be elected at the next annual business meeting. A vacancy in any other elective office, except president, shall be filled by vote of the executive committee.

Amend Article V Officers, Section4 by adding the following sentence to the end of the section: An office vacancy filled by vote of the executive committee shall be elected at the next annual business meeting. If adopted, the section will read:

A vacancy in the office of president-elect shall not be filled. A president shall be elected at the next annual business meeting. A vacancy in any other elective office, except president, shall be filled by vote of the executive committee. An office vacancy filled by vote of the executive committee shall be elected at the next annual business meeting.

Rationale: This amendment clarifies that if it is necessary for the executive committee to appoint an officer, that position is to be filled by election at the next annual business meeting.
