BY-LAWS

By-Laws and Handbook changes to Article VI-Nominations and Elections; Section 1A (page 10). Proposed Amendments to Kansas Association for Family & Community Education Bylaws:

Handbook Currently Reads: -

Each area should elect one member and one alternate to serve on the State Nominating Committee every year at the spring Area Council meeting for one term beginning June 1. The President Shall appoint a former Board Member as chairman of the committee. Members of the committee may succeed themselves once.

Amend Article VI-Nomination and Elections; Section 1 A- Nomination by substituting the following paragraph:

Each Area shall elect one member and one alternate to serve on the State Nominating Committee every year at the FALL Area Council meeting for one term beginning January 1. The president shall appoint a former Board member as the chairman of the Committee for one term beginning January 1. Members of the committee may succeed themselves once.

If adopted, the Article will read:

Each Area shall elect one member and one alternate to serve on the State Nominating Committee every year at the fall Area Council meetings for one term to beginning January 1. The President shall appoint a former Board member as chairperson of the Committee for one term beginning January 1. Members of the committee may succeed themselves once.

Rationale: Clarifies the terms of the State Nominating Committee and the Chair.

Amendment was proposed by the Kansas FCE Board of Directors. This new bylaw change will be voted on at the 2023 KAFCE Conference in Hays, Kansas. Be sure to attend the business meeting to vote on this change,

2022 Program Year State Winners

ACCOMPLISHMENT REPORT: by FCE Unit in Education Category:

First Place: <u>Canton Dizzy Dames FCE</u>, McPherson County, SC Area, Lesson: "Make a Med DASH to a Healthy Heart" Description: Presented lesson to unit and two local groups. A news article was put in two newspapers. A display was made and shown in two locations.

First Place: <u>Sliferette FCE</u>, Crawford County, SE Area. Lesson: "Make a Med DASH to a Healthy Heart" Description: Members created a display poster and handouts that they took to several libraries, TOPPS, several FCE meetings (Aging with Attitude, SE Area Recognition, and State FCE Conference).

Second Place: <u>Starlite FCE</u>, Bourbon County, SE Area. Lesson: "Last Wishes Funeral Planning" Description: All members received material on "Last Wishes" and Hearth Fire Series # 59 booklet. They distributed "Memorial Planning Guide" to 300 at county fair booth.

Second Place <u>Rock 'N Roll FCE</u>, Neosho County, SE Area. Lesson: "Gaslighting" Description: The lesson, written by a unit member, was also given to our unit, SE Area meeting and several other organizations. A three part series of news articles on Gaslighting was written and published in 4 newspapers over 3 weeks. A poster and handouts were made and displayed for 12 weeks in several libraries, busi-

ness, county fair, KAFCE Conference and bank.

Third Place: Farmerettes FCE, Atchison County, NE Area. Lesson: "Destination Oregon" Description: A FCE member chose to portray a historical figure whose family decides to move west, to travel on the Oregon Trail. The presentation provided information of how and what to pack for such an adventure, historical maps and books were passed around to members.

Honorable Mention: <u>Kettle Queens FCE</u>, McPherson County, SC Area. Lesson: "Gaslighting" Description: A large informational display and handouts were made and shown in four locations. The lesson was given to the unit. A newspaper article was written.

ACCOMPLISHMENT REPORT:by Independent Memberin Education CategoryFirst Place: DeLores Walden, NE Area, Lesson: "Last Wishes: Funeral Planning"Description: To inform the community of what they need to know before death, of the DNR directives, advance funeral planning and other information. This was achieved by presenting the lesson to two groups, individuals and booth displays at KAFCE State Conference and NE Area Meeting.

ACCOMPLISHMENT REPORT: by County Council in Education Category:

First Place: <u>Atchison County Council</u>, NE Area. Lesson: "Last Wishes: Funeral Planning" Description: Two funeral home directors, an attorney and director of hospice were asked to be guest speakers at two events, one event at the Atchison City Library, and the other at the funeral home's location. Attendees were glad to hear myths squelched! Many said they were inspired to get their planning done for the benefit of their children's relief. The KAFCE handout and other materials were given to guest. **Second Place:** <u>Allen County Council</u>, SE Area. Lesson: *"More Plants on the Plate"* Description: Provided information at food pantries on how to use various seasonings in food preparation, had a fair booth and newspaper articles. Presented lesson to Southwind Fall Follies and served plant based foods for the evening meal.

Third Place: <u>Crawford County Council</u>, SE Area. Lesson: *"Lower Your Risk of Breast Cancer"* Description: Made a poster which was displayed at several locations, wrote newspaper articles, baked pies for Angels Among Us cancer support group's café at county fair and donated money to the Angels Among Us.

ACCOMPLISHMENT REPORT: by FCE Unit in Action Category First Place: Hobart Homemakers FCE, Rooks County, NW Area, Lesson: "Make a Med DASH to a Healthy Heart!" Description: The group sponsored "Heart and Sole" walks during the summer. After participants walked on the local track, they met on the bleachers for discussion of the lesson of heart health and received handouts. A fair booth was planned and executed.

Second Place: <u>Homemakers FCE</u>, Hodgeman County, SW Area. Lesson: *"Lower Your Risk of Breast Cancer"* Description: Painted 8 life size pink women on the Jetmore Senior Center's display window. The goal was to commemorate National FCE Week and promote October as National Breast Cancer Awareness month. Informative newspaper articles were written.

Third Place: <u>Modern Mrs. FCE</u>, Harvey County, SC Area. Lesson: "*Gas lighting*" Description: The unit served a two meals to 15 women and 10 children at a domestic violence center. These guests may have been victims of gaslighting.

Honorable Mention: <u>Movers and Shakers FCE</u>, Smith County, NW Area. Lesson: "*Gaslighting*" Description: Members constructed a library display, a fair booth and hosted "Lunch and Learn" programs, distributed handouts and provided 2 speakers. Provided materials and information to the FCCLA high school students for their "Star" project.

ACCOMPLISHMENT REPORT: by County Council in Action Category Second Place: <u>Neosho County Council</u>, SE Area. Lesson: "*Last Wishes: Funeral Planning*" Description: Lesson given to 2 units and a study club. Four newspapers in three counties each had two newspaper columns written on the importance of advance funeral planning and one article about writing your own obituary.

Second Place: Johnson County Council, NE Area. Lesson: "Gaslighting"

Description: A speaker from SafeHome, a nonprofit shelter for domestic violence, sexual and physical abuse in Johnson County, spoke at the Council's Fall Workshop. Fifty-four FCE members donated, or purchased SafeHome's requested items such as cleaning products, hygiene needs and bedding supplies. They gathered 371 items! A total \$2,461 was spent or donated SafeHome offers counseling and schooling in addition to housing for victims.

<u>COMMUNITY SERVICE PROJECT</u> by FCE Unit:

First Place: <u>Terry FCE</u>, Atchison County, NE Area Project: "Fluffy Pillows for Gram-Villas Residents" Description: FCE's made 18 fluffy tied fleece decorative pillows for residents. Materials were donated by all FCE. Pillows were stuffed, and tied together at unit meetings.

First Place: **Starlight FCE**, Bourbon County, SE Area Project: "Strengthening Our Community" Description: All members either donated or made goodie bags for emergency responders, veterans, nursing homes, Tri-Valley. They signed 200 cards which were sent to VA hospital on Valentine Day and Christmas. They volunteer at local library and as superintendents at county fair.

First Place: <u>Rock 'N Roll FCE</u>, Neosho County, SE Area Project: "Samaritan's Purse Operation Christmas Child" Description: The unit collected and purchased items for the Samaritan's Purse Operation Christmas Child project which helps children who are victims of disaster. They filled 37 shoe boxes. Second Place: <u>Harmony FCE</u>, Johnson County, NE Area Project: GROW (Grace Restores Over coming Women) Description: GROW director gave suggestions for supporting to the two GROW houses in Johnson County. Collected were new and used clothing. Relationships were developed with the women attending 3 game nights. Four FCE are currently mentors to some of the ladies.

Second Place: <u>Spring Hill FCE</u>, Johnson County, NE Area Project: "Spring Hill Life Spring Food Pantry and School Supplies" Description:

FCE provided Spring Hill needy students with additional food on non-school days. Working with Life Spring Church Food Pantry, money was collected to purchase items for 27 kids. Another 19 kids received school supplies. A total of \$1275 spent and 73 volunteer hours.

Third Place: <u>Kaw Better Homes FCE</u>, Pottawatomie County, NE Area Project: "Celebration of the St. Marys' Senior Center and Remodeling of the Center" Description: The unit supported the St. Marys' Senior Center's mission to provide nutritional meals for elderly, disabled and impoverished households. The unit helped prep food, delivered 26-36 meals each week, and partnered with the center's Board of Directors to sponsor a donor recognition event.

Third Place: <u>Spring Creek FCE</u>, Lane County, SW Area Project: "Youth – Educate, Activate, Motivate" Description: Nine members of Spring Creek FCE planned to support local projects for young families and children. \$1000 was raised. Projects supported were: the 4-H, donation for Halloween and Christmas candy, gifts for 1 Bear Tree child, donation of children's books to the library, and the kids only Christmas Shoppe,

Third Place: <u>Prairie Mates FCE</u>, Russell County, NW Area Project: "Sunflower 4-H Club" Description: The FCE raised \$2,000, and spent 120 volunteer hours to clean and maintain a building in which the Sunflower 4-H club and other organizations could meet. In turn, the 4-H members help the FCE unit during their fundraising hunters' fall dinner.

Honorable Mention: <u>Bluelight FCE</u>, Gray County, SE Area Project: "Random Acts of Kindness Scavenger Hunt" Description: One of the members created a scavenger hunt that would coincide with the Christmas card project. Suggested acts of kindness and Christmas greeting cards were displayed in local businesses for the community to engage in the activities and/or sign the cards.

<u>COMMUNITY SERVICE PROJECT</u> <u>by County Council:</u>

First Place: Atchison County Council, NE Area,

Project: "Family Bonding Thru Yard Games"

Description: Yard games can instill family time togetherness just like board games. Being together, sharing laughter and learning to be good-sports are important tools. The FCE Units of Atchison County planned and executed yard games during two days of the county fair.
