Kansas was successful at the National Family & Community Education Conference in July at Tucson, Arizona. In education category Kansas won second place with members using the Hearth Fire Series #10," Someone's in a Meeting: Making Good Decisions" when applying the lesson "Everyday Can be a Holiday". Kansas won \$300.00 in vouchers for the purchase of educational materials for the upcoming year. Thank all of you who wrote the extra details on your accomplishment report to make the Kansas report a success.

Kansas was successful in receiving Standard of Excellence awards. Northeast area received five gold seals, Southeast received eight, South Central received two and Northwest received four. Membership Awards were issued for 25, 50,55,60,65,70,75,80, and 85 years of membership. 38 were received. FCE (group) Recognition was issued to 6 outstanding groups.

With the challenging financial concerns of the organization we reduced the "KAFCE NEWS" from four issues to three. Along with my monthly FCE Connection we were able to get all the information to members in a timely manner. With the use of the kafce.org website members could get the "NEWS", all forms, scholarship information, and 4th Grade "Essay & Artwork" contest guidelines at their fingertips.

The greatest success is the implementing of the 2014 Lessons. "Focus on the 'Stars' Cooking Healthy for the Holidays" is something we all should use. "Let's Live a Little: Physical Activity for Fun and Fitness" is important as much as eating healthy. And "Food Allergies" is a constant concern for all of us today. Q & A about Franchise Insurance

Why the insurance is needed? If a non-member is attending ANY of our functions and gets injured etc. the insurance will cover the medical bills instead of FCE. Other wise- FCE leaders are on the line for lawsuits.

What it covers? Non-members who may be injured while attending one of our FCE sponsored functions. We all know that the insurance protects us from lawsuits from non-members, and that we can't sue ourselves. Some people are asking what happens if a member gets injured ~ their insurance would cover that. Or if we have to have a certificate if an event is held by Extension ~ no their insurance covers that. It has to be an FCE sponsored event, if FCE members are helping ~ at a health fair, the Red Cross, a literacy program at library ~ all those events are covered by the organization holding the event. Only if an FCE is sponsoring the event are we covered. We are covered whether or not you get the certificate ~ the certificate is necessary when you are asked to show proof of insurance.

We are covered if we give incorrect information in material we distribute (Hearth Fires, FCL) that causes someone to have an injury.

Could the form be emailed to you? Yes, you can email the form to them, they will email back.

How long, once applied for the insurance will the certificate sent? Usually comes back in a few days.

A Board Presentation: "A Nostalgic Walk Through FCE: 1914-2014"

The KAFCE Board, joined by Diane Hanzlicek, immediate past board member, and Judy Fullmer NAFCE Secretary, performed a 100 year history review of Kansas FCE at the recent KAFCE Conference in Parsons, KS. A brief history of Kansas FCE beginnings in 1914 through KAFCE today was compiled by Dorene Reimer, SW KAFCE Area Director. Reimer commented, "The historical research and writing has been done by various authors throughout the hundred years. I read many of them and used parts of those that I thought fit into the flavor of our presentation."

The program was prefaced by clips of 50 musical numbers that were the top songs of the century. As the program progressed, each history clip covered about ten years of FCE development and was followed by a vignette of what might have been a typical FCE unit meeting of that decade. The FCE members were eight state board members, and the audience was included as guests at each meeting. Appropriate decade music at each FCE "meeting" was group singing, led by Diane Hanzlicek and accompanied by Mary Jane Adams at the piano. Over 70 vintage hats, loaned by Dorothea Appl, 2013 KAFCE Heart of FCE, were used for costuming. After each "meeting," appropriate style hats were donned in readiness for the next decade. Vignettes ranged from serious, comical, advisory, and educational, illustrating the fellowship, humor, culture, and relationships women have built in FCE through the years.

The presentation illustrated the mission of FCE: education for families and communities, leadership development, and community service, through which FCE members make a difference in the world in which they live.

National Fundraising Report Judy Fullmer

You will be hearing a lot about finances today ~ your state and national associations are both struggling to find ways to finance the functions of the organization. There were two (2) proposals at the National meeting last July. One was presented by Bob Hannon, a member from Arizona. His idea was to get 400 members/people to donate \$5000 to FCE that would be in an endowment account to help reduce or eliminate the cost of operating FCE locally and nationally. The interest from the fund would be used to maintain the quality of our organization, locally and nationally. The Yuma Arizona FCE Club made one of the first pledges to this fundraiser and challenged the states of Colorado, Kansas, Missouri and Nebraska to match their pledge. For Kansas to make the \$5000 challenge would be approximately \$5.00 per member. There was excitement about this in Arizona, and there were 2 individuals who wrote \$5,000 checks for their donations ~ so there is \$15,000 to start the fund. (There were at least 10 people who came forward during the Kansas conference and matched the \$50, 1 pledged \$100. And one county pledged \$50 and challenged the other 54 counties in Kansas to match that)
